manager in action: Care advocate team helps Joe better manage diabetes



Joe's background

- Joe** has a racing heart and is experiencing weakness and trouble sleeping.
- He checks himself into the hospital and learns he has diabetes.



Nurse care manager approach

- After Joe goes to the hospital, a dedicated nurse contacts him, works with him throughout his stay and prepares him for discharge.
- The nurse sets up a visit from a home health agency, along with follow-up visits to make sure he is comfortable testing his blood sugar.

Outcomes

The nurse follows up often to make sure Joe:

- Understands his care
- Knows how to manage his diabetes in the future
- Has the skills to manage any other health conditions
- Knows about other Aetna programs that can help him
