

Summary Annual Report

For TubeMogul, Inc. 401(k) Plan

This is a summary of the annual report for TubeMogul, Inc. 401(k) Plan, Employer Identification Number 51-0633881, Plan No. 001 for the period January 01, 2020 through April 09, 2020. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided through a trust fund. Plan expenses were \$13,685,502. These expenses included \$975 in administrative expenses and \$13,684,527 in benefits paid to participants and beneficiaries. A total of 0 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$0, as of April 09, 2020 compared to \$15,421,143 as of January 01, 2020. During the plan year, the plan experienced a decrease in its net assets of (\$15,421,143) . This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of (\$1,735,641), including employer contributions of \$0, employee contributions of \$0, and losses from investments of (\$1,735,641) .
